Tribal Cannabis Policy Overview

The Cole Memorandum sets out eight priority areas for federal marijuana enforcement with a focus on public health and safety. This policy statement makes clear that these considerations and limitations apply in Indian Country. The Cole Memorandum does not alter the authority or jurisdiction of the United States to enforce federal law in Indian Country.

Marijuana remains illegal under federal law so it is imperative that tribes work with Congress to facilitate legalization, especially because the federal government has particular authority over law enforcement matters on most reservations. ICIA is developing a plan and strategy to elevate tribal cannabis voices in impending federal legalization as well as the long-term actions for technical assistance and training to ensure tribal communities have access to health & economic development in cannabis.

A Pathway To Significant Scale

Tribally Owned & Operated Dispensaries and Farms*

1998: Washington legalizes medical marijuana.

2012: Washington and Colorado are the first states to legalize recreational marijuana.

2015: Two tribes, Squamish & Squaxin, Green light cannabis after negotiating individual compacts

2024: 23 states allow recreational cannabis sales, 27 states have decriminalized, with Idaho, Nebraska and Kansas continuing traditional probation.

As of 2024, there are nearly 60 tribally owned medical marijuana dispensaries and adult-use stores in nine states.

*Tribally owned & operated includes ONLY tribes; not tribally licensed or tribal member owned which is ICIA's Membership target in addition to Tribally owned businesses, farms, packaging companies, testing facilities, labeling outlets and processors



Indigenous Cannabis Industry Association (ICIA)

2016

\$6.5 billion in reported sales for all state-legal cannabis retail activity with a majority of Indian Country still not engaging in cannabis economic development

2021

\$25 billion in reported sales for all state-legal cannabis retail activity

2026

Experts estimate \$52 billion in cannabis retail activity even if cannabis remains federally illegal

These figures do not include data from Tribal cannabis operations, or entities licensed under tribal authority NOR are they accounting for the LEGAL CBD Market, which according to the FDA's "A New Way Forward" report is expected to exceed \$10 billion by 2027

Consulting with Tribal Leaders and Health Care Providers on Complex areas of Policy and Product Development in the US

- Educating Tribal Leaders to lead on Tribal Regulatory frameworks that protect communities and families from harm
- Advancing Tribally led clinical research on cannabis efficacy that informs and promotes robust scientific research by and for Indigenous communities
- Protecting and Promoting Public Health with respect to cannabis products in Tribal communities (*Increase the agencies resources to include tribal communities alongside federal, state and local)

Organized Efforts to Assist Indian Country in :

The policy reform need is great. ICIA will help lead Indian Country's efforts for federal policy reform leading to the protection of tribal sovereignty in cannabis commerce. Additionally, our legal team is preparing policy impact assessments on behalf of Indian Country to preserve and protect tribal communities in hemp and cannabis.

ICIA Funding Goals

Target: \$2 Million in the next 2 years

Indigenous Cannabis Business Development Fund:

\$.5 million is reserved for Indigenous equity loans and \$.5 million for technical assistance grant awards, cannabis business mentorship programs, workforce curriculum development for TCU's, as well as direct services to Indigenous communities for clemency, expungement and access to work programs for Tribal communities. We plan to hire additional staff to help with the administration of the Tribal CBD Fund Program once funded.

Organized Efforts to Assist Indian Country in Cannabis:

The policy reform need is great. ICIA will help lead Indian Country's efforts for federal legalization advocacy and the protection of tribal sovereignty in cannabis commerce. Additionally, our legal team is prepared for impact litigation on behalf of Indian Country to preserve and protect tribal communities in cannabis.

\$1 million is reserved for operation costs of ICIA to include staff, research, legal analysis, education, policy toolkits, advocacy and events.
